



# **General Regulations for Visitors**

Italian Exhibition Group S.p.A. (hereinafter also referred to as "IEG") has adopted the following General Regulations for Visitors in order to regulate the rules of behaviour of Visitors to the Exhibition Centre of Società Arezzo Fiere e Congressi s.r.l., Arezzo branch, upon:

- registration at the appropriate desk located at the entrances of GOLD/ITALY;
- online pre-registration on the IEG's websites.

These rules are addressed to all the Visitors participating in the Fairs and/or Events organized or hosted by IEG at the Arezzo Exhibition Centre.

Signing this document commits the Visitor to comply with the regulations contained therein.

#### **PROHIBITED CONDUCT**

# Sale of products within the Arezzo Exhibition Centre

The sale of products within the Arezzo Exhibition Centre is strictly prohibited. In the event of a breach of this rule, IEG will be free to avail themselves of the intervention of the Public Safety Authorities that will take appropriate measures against the person responsible for the said violation.

IEG will have the right to ask for the restitution of the entrance ticket issued to the Visitor for access to Arezzo Exhibition Centre.

# Distribution and/or dissemination of promotional or advertising materials inside the Arezzo Exhibition Centre

Distribution and/or dissemination of promotional or advertising materials within the Arezzo Exhibition Centre is prohibited. Visitors found carrying out this activity will have their entrance ticket, valid for free circulation within the Arezzo Exhibition Centre, confiscated immediately.

# Photographs/Videos

Visitors are expressly forbidden from taking photos and making videos within the Arezzo Exhibition Centre unless they have express permission issued by the General Management of IEG. The ban includes photographs and videos made or taken with any type of equipment (smart phones, tablets, digital video recorders, cameras, etc.), as well as drawings and audio recordings. In the event of such a breach, IEG reserves the right to protect, before any competent body, copyright and other related rights. Visitors are also informed that IEG, will personally or via professionals specifically appointed for this purpose, take photographs and/or film video material to document the event on its own website, in publications connected to IEG, and also using other computerized, hard copy and digital formats. Should you wish not to be photographed and/or filmed, please inform the operator, who will be identifiable by special pass.

# **Smoking ban**





Smoking is strictly forbidden within the Arezzo Exhibition Centre; the violation of this regulation will be punished pursuant to Article 51 of Law 3/2003, published in the Official Gazette on 10 January 2005, with a minimum fine of € 27.50 and a maximum fine of € 275.00. It should be noted that, in compliance with the above-mentioned law, the above-mentioned sanction is doubled if the breach is committed in the presence of a pregnant woman, infants or children up to 12 years of age.

Special smoking areas will be made available within the Arezzo Exhibition Centre.

#### Children

Children under 12 years of age are only allowed into the Show on parental delegation. With this delegation, the person accompanying the minor shall be personally responsible for vigilating over the child and shall take full responsibility for any damages caused to persons or things.

#### **Animals**

No dogs or animals of any kind may enter the Exhibition Centre, with the exclusive exception of guide dogs for the visually impaired.

# **VISITOR QUALIFICATION AND ENTRANCE TICKET**

- All Visitors, at the time of registration, must provide evidence of their identity and occupation. In case of misrepresentation, the person concerned will be punishable in accordance with the law.
- At the time of issue of the entrance ticket a current identity document with photograph (passport, identity card) will be required.
- For purposes strictly linked to security and the protection of all those inside the Exhibition Centre, at GOLD/ITALY, the Exhibition specifically for gold and jewellery traders, the entry badge will only and exclusively be issued to persons who, at the time of confirmation, produce a valid identity document and a photograph, which will be inserted into the entry badge and which will allow the visitor to be directly and immediately identified by inspection staff and security personnel.
  - Moreover, the visitor is required to carry a business card and the registration form with the obligatory fields duly completed.
  - IEG reserves the right not to issue the entry badge in the case of false declarations or without a photograph of the interested party. To this regard, IEG hereby reminds you that a photo service is available on-site.
  - On the other hand, for all those who confirm on-line, IEG kindly asks you to read and accept the privacy document. At point 2 in the purposes section, which deals with the afore-mentioned security issues, the reason for data-photo processing is explained and IEG points out that consent it absolutely necessary in order for the interested party to participate at the GOLD/ITALY trade show.
- The entrance ticket is personal and, as such, non-transferable to third parties. If a Visitor is found in possession of another person's entrance ticket, IEG reserves the right to confiscate the entrance ticket and expel the Visitor from the Arezzo Exhibition Centre.





#### **RESPONSIBILITY**

IEG refuses any responsibility for:

- Damage to things and/or injury to people, inside the Arezzo Exhibition Centre except where the damage/harm is attributable to the exclusive responsibility of IEG;
- False and/or deceptive information conveyed through promotional or advertising materials distributed by third parties not authorized by the General Management of IEG.

IEG reserves the right to cancel and/or reprogram Events, and/or Fairs in their calendar. Should an Event and/or Fair be cancelled and/or reprogrammed, IEG has the right to decide whether to refund or not tickets already purchased by Visitors.

In case of refund of entrance tickets, the refund will be made in accordance with the terms and conditions established by IEG.

These General Regulations for Visitors have been drawn up in accordance with Italian Legislation, to which reference must be made for the interpretation of the norms in these Regulations.

IEG reserves the right to change at any time the General Regulations for Visitors. An updated copy of the Regulations will be published on all the IEG's websites and will be effective immediately, from the time of issue.

#### **ACCESS FORBIDDEN**

In addition to what is already indicated by the Consolidated Law on Public Safety Laws (TULPS) for security reasons, access to the fairgrounds is forbidden to persons in possession of own weapons (Article 30) and also to persons in possession of toy weapons, stun devices, blunt instruments, work tools, explosives and incendiary substances and devices and toxic chemicals. Any waivers can be issued only by the Management of Fair Ground.
